## REPORT OF THE SYNOD COUNCIL

From the time of the 2022 Synod Assembly to the time of this report, the Synod Council met 6 times (July 9, 2022, September 24, 2022, January 28, 2023, March 5, 2023, March 18, 2023, and May 13, 2023). This report sets forth the actions of the Synod Council at these meetings.

**Approved** the retirement of Rev. James West on the Roster of Ministers of Word and Sacrament of the Evangelical Lutheran Church in America effective September 1, 2022 (September 24, 2022)

**Approved** the retirement of Rev. Ann Schmid on the Roster of Ministers of Word and Sacrament of the Evangelical Lutheran Church in America effective February 1, 2023. (September 24, 2022)

**Approved** the retirement of Rev. Margaret Suhr-Barkley on the Roster of Ministers of Word and Sacrament of the Evangelical Lutheran Church in America effective July 1, 2023. (March 18, 2023)

## On Leave From Call and Continuation of On Leave From Call

**Continued** the Rev. Larry Kemp in the status of On Leave From Call on the Roster of Ministers of Word and Sacrament of the Evangelical Lutheran Church in America. (July 9, 2022)

**Granted** the Rev. Tara Lynn in the status of On Leave From Call on the Roster of Ministers of Word and Sacrament of the Evangelical Lutheran Church in America up to the completion of her eligible three-year term and/or annual review with the original effective date of August 9, 2022. (September 24, 2022)

**Continued** the Rev. **Received** editorial changes in the "Tri-Synod Archives" documents found in the Synod's Policy Manual, **Referred** it to the Tri-Synod Archives Committee for review and recommendations, and **Directed** the Secretary of the Synod to inform the Synod Councils of the Northwestern Pennsylvania Synod and the West Virginia-Western Maryland Synod of the action taken by our Synod Council. **Adopted** the changes to the "Guidelines for the 'Calendar of Causes'", the "Capital Fund Campaign Request Guidelines", The "Synod Assembly Registration Fee Waiver for Retired Rostered Leaders", "Synod Council Member Expenses for Synod Assemblies", "Congregations Celebrating Significant Anniversaries", "Grant Request Guidelines", "the Installation of Bishop, Synod Officers and Synod Council", and "Pastoral Salary Guidelines" as proposed by the Governance Committee. **Approved** the revision of the resolution titled "Budget and Finance Committee Annual Review of Synod Staff Compensation" as proposed by the Executive Committee. (September 24, 2022)

Archived the LARC Covenant. (January 28, 2023)

**Amended** the Episcopal Bishop's Participation in Synod Assemblies document to include the heads of all local judicatories with which the ELCA has an agreement of full communion. (January 28, 2023)

**Amended** the Membership in Lutheran and Ecumenical Agencies document to change the name Coalition for Public Policy to Advocacy Ministry in Pennsylvania and include language to encourage members of the synod to engage with these ecumenical organizations. (January 28, 2023)

**Nominated** Dennis Lane and Rev. William Schaefer to the Region 8 Pool of Nominees for the Commission for a Renewed Lutheran Church. (March 5, 2023)

Approved the following changes to the Boards of Lutheran SeniorLife and Lutheran Service Society. (March 18, 2023)

- 1. <u>Lutheran Service Society</u>: Reduce the number of SW PA Synod elected clergy/lay members on the Lutheran Service Society board from 4 to 2.
- 2. <u>Lutheran SeniorLife</u>: Reduce the number of SW PA Synod elected ordained ministers/deacons on the Lutheran SeniorLife Board from three (3) to two (2).
- 3. Revise process to enable SW PA Synod Council to approve Lutheran SeniorLife board nominees rather than have them elected by the SW PA Synod Assembly.
- 4. Revise process to enable SW PA Synod Council to approve Lutheran Service Society board nominees rather than have them elected by the SW PA Synod Assembly.

# Synod Assembly

**Created** a Domestic Violence Task Force to work with the Presbyterians Against Domestic Violence Network and housed that task force under the Church in Society Committee. (Per Synod Assembly Action SA22.06.06) (July 9, 2022)

**Deleted** lines 32-41 of the amended Mustard Seed Memorial that was adopted by the 2022 Synod Assembly and inserted the word "Further" after "Be It" in line 43 so that the Memorial would now reflect the intended action of the Synod Assembly. (July 9, 2022)

**Took no action** on the resolution entitled, "Evaluation of Budget Line Item on Rent and Utilities" that was referred to the Synod Council by the 2022 Synod Assembly as the action being requested under the resolved section is already enumerated in the Bulletin of Reports of the Synod (July 9, 2022)

Approved the Minutes of the 2022 Synod Assembly (September 24, 2022)

Allocated \$1000 total per Conference to fund the Mustard Seed Initiatives through the 2023 Synod Assembly. If a

Conference has an initiative that exceeds \$1000, it may bring it to the Synod Council for consideration. (September 24, 2022)

**Voted** to hold the 2023 Synod Assembly on June 16-17, 2023, with Friday, June 16 being held on ZOOM and Saturday, June 17 held in person at Penn West University – California with a cost for each attendee to be set at \$75.00. (January 28, 2023)

Approved the Synod Assembly Lay Voting Member Formula as recommended by the Credentials Committee:

- 1. That each congregation, irrespective of baptized membership, may elect two voting members
- 2. That an additional voting member be elected, based on baptized membership above 500 but below 750, an additional two voting members be elected for those congregations with a baptized membership above 750 but below 1,000, and that an additional three voting members be elected for those congregations with a baptized membership above 1,000. And that each increment of 250 above 1,000 baptized members provide an additional voting member for the congregation to elect. (January 28, 2023)

**Nominated** Rev. James Arter and Rev. William A. Schaefer for the position of Secretary at the 2023 Synod Assembly. (March 18, 2023)

Adopted revisions to the financial documents of the Synod Policy Manual. (March 18, 2023)

**Amended** the proposed agenda for the 2023 Synod Assembly to insert the inclusion of the proposed amendment to bylaw B7.11.11. and the rule to set the time for speeches immediately after the Adoption of the Agenda.(May 13, 2023)

**Designated** the offerings from the worship service of the 2023 Synod Assembly to ministries related to our Companion Synod in Madagascar. (May 13, 2023)

# Recommendations to the 2023 Synod Assembly

- 1. To adopt the Program and Order of Business for the 2023 Synod Assembly.
- 2. To amend Bylaw B7.11.11. to read:

B7.11.11. Each voting member, or those persons accorded the privilege of seat and/or voice, when recognized by the chair, shall state his or her name, and the name of the congregation, institution, or group he or she represents. Persons speaking from the floor of the Synod Assembly shall use the floor microphones (if they are provided) and shall address and speak to the chair. Such speeches shall be limited to 5 minutes on each Synod Assembly issue. Speakers may speak a second time on the same issue, but only after all others desiring to speak have been given opportunity to do so. Those speaking a second time shall be limited to 2 minutes. The time limits for each speaker shall be set in the rules of the Synod Assembly.

and set the following rule for the 2023 Synod Assembly:

Speeches shall be limited to 3 minutes on each Synod Assembly issue. Speakers may speak a second time on the same issue, but only after all others desiring to speak have been given the opportunity to do so. Those speaking a second time shall be limited to 2 minutes.

3. To adopt the following additional rules for the 2023 Synod Assembly:

A voting member may not introduce a motion after first speaking to the matter but shall be afforded the first opportunity to speak following receipt of a second, including "calling the previous question."

Any voting member may request, for separate consideration, the removal of any item from the en bloc recommendations of the changes to the Synod Constitution and Bylaws. All requests for the removal of these items must be received by the Secretary of the Synod in writing no later than 11:00 AM on Saturday, June 17, 2023.

Business items being brought before the Assembly that are not on the agenda must be submitted in writing to the Committee on Reference and Counsel no later than 11:00 AM on Saturday or they will not be considered.

Any motion from the floor of the Synod Assembly to amend the proposed budget (1) must be submitted in writing to the Secretary of the Synod by 10:15 AM on Saturday, June 17, 2023, (2) that any proposed amendment to increase any line item of the proposed budget must include an offsetting reduction to another line item(s) in order to maintain the parameters of the proposed budget; (3) must be referred to the Committee on Reference and Counsel so that representatives of the Budget and Finance Committee can provide input on the proposed change(s) and the implication(s) of those changes prior to the Assembly's vote on the proposed budget.

- 4. To approve the first reading of Group A (Constitution Changes) of the recommended changes to the Synod Constitution. (See "Exhibit A")
- 5. To approve Group B (Constitution Changes Recommended by the 2022 Churchwide Assembly) of the recommended changes to the Synod Constitution. (See "Exhibit B")
- 6. To approve Group C (Bylaw Changes) of the recommended changes to the Synod Bylaws. (See "Exhibit C")
- 7. To approve the 2024 Synod Budget. (See "Exhibit D")
- 8. To approve the following Mission Support Formula for 2024: "The faithful people who make up the congregations of our SWPA Synod of the Evangelical Lutheran Church in America endeavor to live lives of generosity and healthy stewardship. We believe that all we have is a gift from God ourselves, our time, and our possessions, signs of God's gracious love for us. We aspire to give back a portion of every gift to God through the hands and feet of our local churches. We recognize that our Synod further extends the reach of the church into the lives of people both locally and globally. Our congregations are encouraged to give at least a tithe of gifts and offerings to Mission Support. We challenge each other to give a faithful measure of our congregation's gifts to the work of our Synod. Congregational leaders may request consultation with our Synod Council to assist in determining their proportionate share. We are called to live faithful lives to the bold witness of life-everlasting through our savior Jesus Christ, who sacrificed everything for us and calls us to follow in his footsteps and boldly sacrifice everything for our neighbor. May God work in our hearts and in our congregations to give faithfully so that God's hands and feet never stop serving our neighbors."
- 9. To approve the 2024 Compensation Guidelines for Ministers of Word and Sacrament. (See "Exhibit E")
- 10. To approve the 2024 Compensation Guidelines for Ministers of Word and Service. (See "Exhibit F")
- 11. To approve the 2024 Interim Ministry Guidelines. (See "Exhibit G")
- 12. To amend the "Minimum Compensation Requirement for Placement of Pastors" by striking the words in the title "the placement of pastors" and inserting "Providing Candidates for Call" and in the striking the words "placing pastors" from the body of the text and inserting "providing candidates for call".
