# **Stewardship and Finance Committee**

Happy New Year to all of you! As of this writing just a few days into the new year of 2024, I am happy to report that \$3,899.50 was donated to our 2023 designated outreach, TryLife Center, in addition to many material items. Our women's organization also donated through the SWO board offerings to: East Palestine, Ohio (\$470) to help those effected by the train accident in that area, Katie's fund (\$50) and Lutherlyn (\$160). An additional \$250 in board offerings was donated to ELCA Good Gifts to: feed a refugee family for one month (\$200), school fees and uniforms for a girl (\$40), and chicks for God's Global Barnyard (\$10). SWPA Women of the ELCA you are amazing and it shows through the love and joy that you continue to share with others.

My 2<sup>nd</sup> term as treasurer on the SWPA SWO board ends on January 31<sup>st</sup>. I want to take this opportunity to thank you for allowing me to serve the Women of the SWPA. It has truly been a learning experience, especially when everything shut down at the beginning of my 1<sup>st</sup> term due to the pandemic and working with the board to figure out how to adjust for us to continue God's work smoothly and efficiently to the benefit of all the ladies. This continued into my 2<sup>nd</sup> term as things were returning to a new normal and we slowly returned to in-person meetings while still maintaining to reach those ladies that were served best by virtual meetings. # **Social and Racial Justice**

The Gathering at the 12<sup>th</sup> Triennial Convention in Phoenix Arizona offered a wonderful presentation by individuals from the Pine Ridge Indian Reservation in South Dakota. One thing we learned, is they wish to obtain back the land which the US took from the Native Americans. The Black Hills were promised to the Lakota people until gold was discovered. They told us that not one treaty made with the Native Americans was broken by the Native Americans. They were all broken by the United States Government. A lot of promises made to them were not fulfilled. All the speakers were enlightening.

Janet Fishovitz's husband Tony, two more members of their congregation plus Pastor Dennis Orsen visited the Pine Ridge reservation this past summer. One person they met was a Lakota woman who makes jewelry from porcupine quills. She dyes the quills herself. While talking to the group, she held quills in her

mouth and made jewelry. The quills did not puncture her mouth. She makes bracelets, earrings, necklaces and more. Very delicate and pretty.

There is a wonderful program on PBS about the history of the buffalo. The Dakota only hunted the buffalo for food and used their skins for clothing and other necessary items, check your PBS programming to see this very informative program.

Pat Bellingham, from NWPA, gave an exceptional presentation on both sexual and labor trafficking. We need to remember the indigenous people and victims of sexual and labor trafficking in our prayers.

The Welcoming Immigrants Housing Project at Emmanuel Eastmont continues to accompany and help asylum seekers from many countries. They receive many requests for rental and medical assistance. They have a close relationship with five families. In addition, they granted one-time financial help. An Ethel Verney grant from our synod and contributions from individuals and congregations fund this work. The need is great. There is also good news. One couple was granted asylum in February by their immigration judge after he heard how her mother and brother were killed by the rebels in her country and how the rest of the family continues to be threatened. We have received New Years greetings from **Sisters Celebrating Diversity**. The 2022-23 year was the seventh year of this group that fosters racial understanding and unity among Christian women. The leadership team took the seventh year as a time of Sabbath rest and discernment. In January they offered a discussion on Embracing Our Neighbors. On February 29, there will be a presentation at the Bethel AME Church in the Hill District of Pittsburgh. The host congregation lost their land and a significant church building when the Civic arena was built. Last year they received the land back and are building much needed new housing. Our 2023 Designated Outreach, TryLife Center and their board would like to thank everyone for their support. At the retreat this fall, we collected \$454.00, and large boxes of clothes and shoes, 20+ packs of diapers, wipes, a diaper pail with liners, and homemade quilted covers for car seats for infants so they will not get cold this winter. The total amount given this year was \$3,899.50 along with Pedialyte, baby food, crocheted blankets, and MORE diapers and wipes.

They receive snacks, tutoring, play games, make crafts, and have free play time too at NO COST to those who qualify. All are welcome to attend their program. Material assistance needed are:

  - a) Written response on application
  - b) Consideration for first time participants
- 4. After the deadline, award decisions will be made by the Personal & Participation Growth Committee based on the guidelines.
- 5. Grant applicants will be notified of award of Grant within two weeks of the application deadline.
- 6. Grant recipients must mail their registration, along with the reduced fee, to event Registrar.
- 7. Grant recipient names will not be published.


